**NOTICE OF HEARING**

Pursuant to Hawaii Revised Statutes ("HRS") section 431:10C-410 and section 91-9.5, notice is hereby given that the Insurance Division ("Division") will hold a public hearing on October 2, 2025 at 10:00 a.m. in the Queen Kapiolani Conference Room, 2nd Floor, King Kalakaua Building, Department of Commerce and Consumer Affairs, 335 Merchant Street, Honolulu, Hawaii 96813, to hear all persons interested in AIPSO Filing No. 4854 which was submitted by AIPSO to the Division on behalf of the Hawai'i Joint Underwriting Plan ("HJUP").

The purpose of the filing is a consent to rate submission to request a \$100,000/\$300,000/\$30,000 split limit liability coverage for a 2005 Freightliner Tractor and

semitrailer used in a commercial driving school. Reportedly, the vehicle is not equipped with dual controls. Since the matter was referred to AIPSO in accordance with Rule 134 of the Manual, the proposal is that the truck-tractor be rated using 200% of the appropriate local, commercial truck rate for the territory of garaging. Additionally, AIPSO proposed that the semitrailer be rated using the otherwise applicable semitrailer rate.
