Re: **Oceanic Time Warner Cable LLC, Kauai Cable Television Franchise**

Dear Ms. Yamamoto:

On November 18, 2016, the Department of Commerce and Consumer Affairs ("DCCA") informed Oceanic Time Warner Cable LLC ("OTWC") that the ascertainment proceeding for the renewal of OTWC's Kauai franchise was completed. As you are aware, pursuant to Hawaii Administrative Rules ("HAR") §16-133-28, OTWC is required to submit a written application for renewal of its Kauai cable franchise within twenty-eight (28) calendar days from the date of the letter (i.e., on or before December 16, 2016).

OTWC's current Kauai franchise expires on December 31, 2016. However, given that OTWC has yet to submit its Kauai franchise renewal application and DCCA anticipates, among other things: (1) holding at least one (1) public hearing on OTWC's yet to be filed application on the island of Kauai; and (2) conducting discussions on outstanding issues and concerns raised by the public, an extension of OTWC's current Kauai franchise is, under the circumstances, appropriate and reasonable.

In view of the above, DCCA and OTWC hereby mutually agree (as acknowledged below) to extend the term of OTWC's current Kauai franchise from December 31, 2016 to March 18, 2017. Both parties hereby reserve all rights under

applicable provisions of the Cable Act, including, without limitation, Sections 546 and 555 of Title 47 of the United States Code. Nothing herein shall be deemed or construed as a waiver, release or surrender of any right that either party may have under the Cable Act or any applicable law or regulation.
