Requests a determination on: (1) whether a C-41 Reinforcing steel contractor is required to perform the reinforcing steel work; (2) whether the reinforcing steel work is “incidental and supplement” to the C-31a Cement concrete classification held by a general contractor; and (3) whether an “A” General engineering or “B” General building contractor may self-perform the reinforcing steel work.

A licensed C-41 Reinforcing steel contractor will be fabricating all rebar work offsite and deliver to the jobsite. The general contractor with an “A” and “B” license will construct the concrete stairs and concrete curb.

The total amount of bid for Project is \$769,096.80.

The total cost of the C-31a Cement concrete portion of the project is \$156,000 (Concrete Stairs: \$89,000, Concrete Curbs: \$67,000)

The cost of the individual components for the C-41 Reinforcing steel work is \$20,922 (Materials: \$20,502, Delivery: \$420)
