The fencing work consists of a 14-foot wide by 6 foot high double-swing gate and approximately 730 linear feet of chain-link fence; the gate and fence are topped with an extension arm and three strands of barbed wire. There is also a fence for the stairs on each tank which consists of approximately 19.5 linear feet which follows the elevation of the stairs between two landings. The fence is 8-foot high metal security mesh fence topped with an extension arm and three strands of barbed wire. The gate for this fence will allow for entry via a cyberlock.

Requesting a determination on: (1) Whether a C-32 Ornamental, guardrail, and fencing contractor’s license is required to perform the fencing work; and (2) Whether the C-27 Landscaping classification includes the work of the C-32 contractor.
