NOTICE OF HEARING

Pursuant to Hawaii Revised Statutes ("HRS") section 431:10C-410 and section 91-9.5, notice is hereby given that the Insurance Division ("Division") will hold a public hearing on May 29, 2025 at 10:00 A.M. in the Princess Likelike Conference Room, 3rd Floor, King Kalakaua Building, Department of Commerce and Consumer Affairs, 335 Merchant Street, Honolulu, Hawaii 96813, to hear all persons interested in AIPSO Filing No. IRS-4834 which was submitted by AIPSO to the Division on behalf of the Hawai'i Joint Underwriting Plan ("HJUP").

The purpose of the filing is an individual risk submission to request a \$100/300/50 split limit liability coverage for a 1995 Freightliner Tractor and semitrailer used in a commercial

driving school. Reportedly, the vehicle is not equipped with dual controls. Since the matter was referred to AIPSO in accordance with Rule 134 of the Manual, the proposal is that the truck-tractor be rated using 200% of the appropriate local, commercial truck rate for the territory of garaging. Additionally, AIPSO proposed that the semitrailer be rated using the otherwise applicable semitrailer rate.

A copy of the proposed filing may be obtained for a \$2.50 charge before the date of the hearing between 7:45 a.m. and 4:30 p.m., Monday through Friday, excluding holidays, at the following address: Department of Commerce and Consumer Affairs, Insurance Division, 335 Merchant Street, Room 213, Honolulu, Hawaii 96813. The \$2.50 charge will be due and payable at the time of picking up the proposed filing.

The Insurance Division intends to make its decision on the proposed filing at the time of the hearing.
