When recognized by the Chairperson, please unmute your microphone before speaking and mute your microphone after you finish speaking.

PHONE ACCESS:

Upon dialing the number, you will be prompted to enter the Meeting ID which is also listed at the top of the agenda.  - 1) HB 2415, HD2, SD1 (or latest version of the bill) Relating to the Nurse Licensure Compact Authorizes the Governor to enter the State into the multistate Nurse Licensure Compact, which will allow a nurse who is licensed by a home state to practice under a multistate licensure privilege in each party state. Beginning 7/1/2026, authorizes the State Board of Nursing to charge different fees customarily and historically charged for registered nurses and licensed practical nurses who hold a multistate license issued by the State. Takes effect 7/1/3000; provided that the Nurse Licensure Compact shall become effective and binding in the State after enactment of this Act. (SD1)
 - 2) SB 2492, SD2 (or latest version of the bill) Relating to the Nurse Licensure Compact Allows the Governor to enter the State into the multistate Nurse Licensure Compact, which will allow a nurse who is licensed by a home state to practice under a multi-state licensure privilege in each party state, effective 1/1/2026. Beginning 1/1/2026, allows the State Board of Nursing to charge different fees for registered nurses and licensed practical nurses who hold a multistate license issued by the State. Takes effect 7/1/2040. (SD2)
 - 3) HB 2079, HD2 (or latest version of the bill) Relating to Health Relaxes the requirements for prescribing certain controlled substances as part of gender-affirming health care services. Expands the protections established under Act 2, SLH 2023, to include gender-affirming health care services. Clarifies jurisdiction under the Uniform Child-Custody Jurisdiction and Enforcement Act for cases involving children who obtain gender-affirming health care services. Effective 7/1/3000. (HD2)
 - 4) HB 1675, HD1, SD1 (or latest version of the bill) Relating to the General Excise Tax Exempts from the general excise tax amounts received by a hospital, infirmary, medical clinic, health care facility, pharmacy, or a medical practitioner for health care related goods and services purchased under Medicaid, Medicare, or TRICARE. Takes effect 12/31/2050. Sunsets 1/1/2026. (SD1)
 - 5) HCR 187/HR 167, HD1 (or latest version of the reso) Requesting the Department of Health to Convene and Health Care Facilities Labor standards Working Group to Research, Assess, and Make Recommendations on Best Practices in Labor Standards that Can Be Implemented at Hospitals, Care Homes, and Dialysis Facilities in the State – Names the Chair of the Board of Nursing or designee, to Chair this Working Group
